

Ercros informa de la compra de 165.620 accions pròpies

La Societat informa que, a l'empara del cinquè programa de recompra d'accions pròpies per amortitzar, durant el període transcorregut entre el 17 i el 23 d'abril de 2020, ha portat a terme la compra de 165.620 accions pròpies.

Des de l'inici d'aquest programa fins ahir, la Societat ha desemborsat 8.735 milers d'euros, import que completa el *payout* previst amb càrrec al benefici de 2019. En l'actualitat, la Societat posseeix 3.944.584 accions en autocartera per a amortitzar, que equivalen al 3,76% del capital social.
