RELEVANT INFORMATION

As a continuation of the relevant information number 9962 published on June 11, 2021, the Company informs that, under the sixth program for the repurchase of treasury shares to be redeemed, during the period between August 19 and 27, 2021 has carried out the purchase of 82,388 treasury shares.

Currently, the Company holds 1,713,425 treasury shares (1.70%).
