RELEVANT INFORMATION

As a continuation of the relevant information number 9962 published on June 11, 2021, the Company informs that, under the sixth program for the repurchase of treasury shares to be redeemed, during the period between July 30 and August 9, 2021, has carried out the purchase of 81,000 treasury shares.

Currently, the Company holds 1,536,037 treasury shares (1.52%).
