RELEVANT INFORMATION

As a continuation of the relevant information number 9962 published on June 11, 2021, the Company informs that, under the sixth program for the repurchase of treasury shares to be redeemed, during the period between September 8 and 16, 2021 has carried out the purchase of 81,741 treasury shares.

Currently, the Company holds 1,871,612 treasury shares (1.85%).
